Thank you for your generous and high quality volunteer service during the 2010 Income Tax season. This year, the Volunteer Income Tax Assistance (VITA) Team assisted 149 Coast Guard military, civilian, retiree, and dependent personnel in preparing their 2009 tax returns, saving eligible members over \$29,000 in tax preparation and filing fees. The VITA Team's hard work and dedication resulted in over \$41,000 worth of state refunds and over \$335,000 in federal refunds for eligible members.
